Nete kamashtueshintunants nete Nfld mak Labrador (kaueshintunants) katapuetak nenu meshananekenu. Meunenu kaitshinuesht uin tshetshi tapuetak.

Ume uishaiueueshintunants entshe auentshi kamatshatutuakenets nete kashkutamashuts put katauakue nete Newfoundland mak Labrador uassets kakanuenamakanets enta nessapishum 1, 1973 nashpesh uapukuenpishum 28, 1989. Nenua kashkutamatsheutshiuapa tsheuauitakentshi:

- Whitbourne Kashkutamatsheutshiuap, uassets kashkutamatsheutshiuapau, uassets kanakatuenamakanets napesets.
- Pleasantville kashkatumatsheutshiuap, eapets neshkuesets kanakatuenamakenets, ekuet eapets nashkuesets nakatuenamakanipents uipets nete Tobay mak St John's mak
- St John's uassets kanakatuenamakenets.

Kaueshintunants kanashaniatets kanantusenitakents tshakuan mak auentshi katats, kauetanankenets tshetshi tats Jane Auen (#7), John auen (#10) mak kuetek John Auen (#11) kie kaitshinuesht eapets uishamakanipan kie nenua katushkuat Morris Martin Moore nete Mount Pearl ne kuetek kaitshinuesht.

Kamamashishemut mak ne tsheutshamau mamu tapuetamupants tshetshi tshishtutas nenu kenantusenitakenua tshakuan ute keuashitunants. Tapuetahe tshakamakunesht mishue tshakuan ute kaueshintunanets, Tsheutshamau tshakatshishiashu \$12,500,000.00 tshetshi minakenets entshe auentshi kapitakatats mueshananekenuau nete kaueshintunanets, kie passe kaitshinueshets tshakatshishiakuets mak nenu tshakuan tshetshishias, mak ente kuetek tshakuan tshetshishiakents essiu utishapents. Kaitshinueshets ntuenitamuets tshetshi minakenets essi tashkatas \$3,125,000.00 mak tax kie kuetaka tshakuana tshetshishias \$58,899.89 mak mamu tax.

Tshekatetaunakenu ne shuneau tsheminakenets entshe auentshi kamamashishemuets kie nenu eshauakenets tshetshishiuakenets, \$500,000.00 kantuenitak piek auen. Tsheutshamau ettu tshekatshishiashu \$250,000.00 kie \$25,000.00 tshekakasthanem auen nenu essi meshtanak ushuneam.

Tapuetahe nass mishue tshakamakunuesht tshakuan kie minakentaue shuneanu auentshi, tsheka meshanaushuets auentshi meshananekenu tshetshika minuats petutats mueshananekenuau tshetshi ueueshaets tsheutshamau nenu kamentutuakenets put kie emashtutuakenets nete kashkutamatsheutshiuapish.

Tshekai tapuetum tshakamakunuesht nenu meshananekenu eshk eka takuenets shuneanu.

Tapuetakune tshetshi minakuen ketshin shuneau, tshekatshi menapuen put kantashename tshemashananeken tshenashtapa.

Tshatshi muk kuetek tshakuan tute:

1. **Tshemashanantshe:** tshemashanamuets ne kuinakenua nashuk shuneanu kenutshiemua lamanuenitame eshatshishiuakenets kaitshinueshets kie nenu eshuatanass shuneanu kie tshenasishueuet tshetshika tapuetuakenets nenu eshatuenitas nete kaueshintunanets. Tshekusi meshanantshe eshk eka uetishapents uapakuenapishum (June) 8, 2022
2. **Uitakuashene:** Tshekatakueshenen kaitakuashene nete kaueshintunants. Muk tshekusi nesishue tshetshi nesishuen tshakuan nte anamueatekentshe tshemashananeken. Nta uapukunapishum 15, mak 16, 2022 tshekatshitapatakenu tshemashananeken kie tshekanamuetakenu nete St John's Newfoundland mak Labrador kameshtueshintunants.
3. **Kai tutame tshakuan:** Uipunikame mishue tshemashananeken kantushtan nete kaueshintunants tshetshi minakun shuneau.

Tapuetakentshe meshananeken kapitakatakents nte kaueshintunants tapuetashe tshkamakunesht, tshkui tapuete meshananeken eteshtets mishiue. Eku kataputakentshe ne meshananeken katapuetashe tshkamakunesht tshkatshi nashtesh auen kashtanum tshkuanu.

4. Eshk ekanita ueshitats kie nteshanas mueshanekenuau tshetshi ntuenitas shuneanu.

6. Eku entshe ekatats Newfoundland mak Labrador, tshash ene uinuau punitauets mueshanekenuau.
